- Only one person may approach the podium at any given time, and only the person at the podium, upon recognition by the presiding officer, will be allowed to speak for no more than (3) minutes unless otherwise directed by the presiding officer;
- Speakers must address their comments to the presiding officer rather than individual City Council members or staff; and
- Speakers may file copies of their remarks or supporting information with the City Secretary who will make the information available to the City Council if requested

The Council will be allowed to receive input or information for a future agenda item but will not be allowed to enter any discussions. The Council shall allot a maximum of fifteen (15) minutes for "Citizen Participation" during a designated Council Meeting.
