## CITIZEN PARTICIPATION:

- Speakers must address their comments to the presiding officer rather than individual City Council members or staff; and
- Speakers may file copies of their remarks or supporting information with the City Secretary who will make the information available to the City Council if requested

The Council will be allowed to receive input or information for a future agenda item, but will not be allowed to enter any discussions. The Council shall allot a maximum of fifteen (15) minutes for "Citizen Participation" during a designated Council Meeting.
