## CITIZEN PARTICIPATION:

  to the City Council if requested

The Council will be allowed to receive input or information for a future agenda item, but will not be allowed to enter any discussions. The Council shall allot a maximum of fifteen (15) minutes for "Citizen Participation" during a designated Council Meeting.
